## Guide to completing this application

### Application for Pilotage Exemption

- Complete pages 1 and 2 of this application.
  
- **The following must be lodged with this application:**
  1. A Copy of your valid passport.
  2. A Copy of your valid residence visa, or visa processing documents during the probationary period in which you must also have done the medical examination at Al Sharq Medical Centre as disseminated previously through notice to agent no. 20/2009.
  3. Two (2) passport size photographs.
  4. A Copy of your Continuous Discharge Certificate C.D.C.
  5. A Copy of your Certificate of Competency C.o.C
  6. A Copy of your C.o.C endorsement.
  7. A Copy of the Safe Manning Document.
  8. Vessel(s)' Particulars.
  9. A Copy of the charter party, if applicable.
  
- The applicant shall complete a minimum of 20 trips in and out of the port among which 10 trips shall be at dark hours. Details of the trips, on page 2, shall be filled out, signed and stamped accordingly.
  
- **The examination will consist of two sections:**
  - I. Written examination, including filling in of details on a blank chart.
  - II. The candidate should satisfy the examiner with his knowledge of Port Rules and Regulations, management of waters and any matter not covered in the written section.

# Application for Marine Pilotage Exemption

- **Knowledge of the following is required:**
  - a. Relevant Port Rules and Regulations.
  - b. Navigational marks including SPM buoys with their descriptions, light characteristics and fog signals.
  - c. Berth numbers and their locations.
  - d. Depths at berths and approaches.
  - e. Anchorage areas, restricted and naval waters.
  - f. Speed zone and reporting points within the port limit.
  - g. Standard marine communication phrases.
  - h. VHF practice on approach.
  - i. English language skills that enable problem-free communication.
  - j. Matters of significance to safety and the environment in the relevant areas, including emergency preparedness
