## **SEVEN METRE STORAGE BAYS – CONDITIONS OF USE**

1. Bays are rented out on the understanding that they are to be used for the temporary storage of goods in transit between supply vessels and the Port or vice versa.
2. Goods stored in Bays must conform to the requirements issued periodically by the Port's Operation Department.
3. The Lessee is responsible for the Bays' cleanliness and condition.
4. A signboard identifies the Company Name to be fixed on the fence.
5. Goods stored in the allocated Bay remain, in all respects, the responsibility of the Bay Lessee.
6. No hazards to be stored (Paint and Lube oil drums are exempted).
7. Company will be responsible for any breaches of the above terms and responsibilities.
