Further to our Notice to Mariner No. 192 dated 03/06/2015 and Notice To Mariner no.182 dated 7 July 2014, it has come to our attention that the “**Association Of Ships Safety(A.S.S.Ltd)**” is issuing fraudulent invoices with the intent to defraud. For your information, **Association Of Ships Safety(A.S.S.Ltd)** is not Registered with Port of Fujairah and they are not authorized to deal with any type of marine wastes in Fujairah.

Reception Facilities other than those listed in our Notice to Mariner No. 148 Version 2 are not allowed to issue or issue on behalf of permitted companies the receipts or invoices against the waste materials disposed in Fujairah.

Strict action will be taken against companies or persons involved in the issuance of counterfeit receipts or fraudulent invoices against the waste materials disposed in Fujairah.

The below listed companies are still under close observation for their fake identities and defrauding. If you think that this type of fraud has already happened to you, please contact us immediately with copy of the invoices.
