**Notice to Mariner No. 309**

**SUBJECT : CHANGE IN SHIP'S INFORMATION  
AMENDMENT TO NOTICE TO MARINER NO. 148 V 6  
SECTION I – GENERAL INFORMATION**


Change of Ship's information regardless of vessel type at Port of Fujairah is permitted, subject to the following,

- Any change in ship information should be requested to Harbour Master's Office 48 hours prior ship's arrival.
- Once the vessel drops anchor or is safely moored at respective berth, copies of the following certificates need to be submitted to Marine Department with the changes.
  - Ship Registry.
  - Deletion Certificate (if applicable).
  - CLC, CLBC and WRC.
- The date of change / amendment of registry and other relevant certificates should NOT be before she arrives at Fujairah waters.
- P & I Certificate of entry and CLC, CLBC, WRC insurance must remain in force throughout the duration of her stay in Fujairah Waters before, during and after the changes are made, so as to avoid any gap in insurance cover.
- After submitting the aforementioned documents, approval will be given and vessel can reflect changes on the hull (if applicable) by submitting a request to the HSSE Officer – Marine.
- Vessel and her local shipping agency should report immediately after change of ship's particulars has been made.

- g. Ship Certificates as per Section II of Notice to Mariner No 148 Version 6 should be submitted including Continuous Synopsis Record before departure.
- h. All attestations and other requests prior information change will be accepted with the present name.
