## Notice to Mariner No. 318

SUBJECT

: CHANGE IN SHIP'S INFORMATION

AMENDMENT TO NOTICE TO MARINER NO. 309

SECTION I – GENERAL INFORMATION - 148 V 6

Further to our Notice to Mariner No. 309 dated 02 February 2022, change of information in AIS should be considered only after submitting the required documents and approval from the Harbour Master. With the inclusion of aforementioned condition, the requirement for change of Ship's information regardless of vessel type at Port of Fujairah is amended as follows,

- a. Any change in ship information should be requested to Harbour Master's Office 48 hours prior ship's arrival.
- b. Once the vessel drops anchor or is safely moored at respective berth, copies of the following certificates need to be submitted to Marine Department with the changes.
  - 1. Ship Registry.
  - 2. Deletion Certificate (if applicable).
  - 3. CLC, CLBC and WRC.
- c. The date of change / amendment of registry and other relevant certificates should NOT be before she arrives at Fujairah waters.
- d. P & I Certificate of entry and CLC, CLBC, WRC insurance must remain in force throughout the duration of her stay in Fujairah Waters before, during and after the changes are made, so as to avoid any gap in insurance cover.
- e. After submitting the aforementioned documents, approval will be given and vessel can reflect changes on the <u>hull (if applicable) and AIS</u> by submitting a request to the HSSE Officer Marine.

- f. Vessel and her local shipping agency should report immediately after change of ship's particulars has been made.
- g. Amended Ship Certificates as per Section II of Notice to Mariner No 148 Version 6 including Continuous Synopsis Record should be submitted before departure of the vessel.
- h. All attestations and other requests prior information change will be accepted with the present name.

This Notice to Mariner supersedes our earlier Notice to Mariner No. 309
